Made Model Kft. (registered office: 1126 Budapest, Tartsay Vilmos utca 22., company registration number: 01-09-959306) provides the platform, named "net-casting.eu" which is used by Made Model Kft. to send newsletters to you as a person interested in the activities of fashion, film, commercial, promotion, art, and cultural jobs. In order to enable Made Model Kft. to provide you with the newsletter and recruitment service, Made Model Kft. needs to store your data and transfer your contact data to its service provider business partners that also guarantee safe data-storage and processes.

Please note that Made Model Kft.(hereinafter referred to as: Agency) is planning to use a common system for marketing purposes (newsletter provider /as mailchimp/ database software /as forge/) and all the marketing activities will be realized through this systems. The Made Model Kft.' marketing departments and the regional marketing department will have access to this system and to the contact data uploaded into the system. With regard to the before mentioned, Made Model Kft. entities would like to upload your contact data into this system. Please be informed that systems above are developed by independent however accredited and licensed corporations.

With regard to the data privacy changes after 25 May 2018, when the General Data Protection Regulation of the European Union becomes applicable to all data control carried out in the territory of the European Union, processing of personal data for bilateral purposes may be regarded as carried out for a legitimate interest, which means that no consent would be required from your side. Notwithstanding Agency would like to follow the safest practice and would like to obtain your consent for data management for those purposes. Please provide Made Model Kft. with your consent as per below. Please note that without your consent, Made Model Kft. will not be able to send you newsletters and event invitations or directly contact you with any recruitment activities.

In case where the data processing include the transfer outside of the European Union (EU) the transfer is based on EU approved standard contractual clauses, thus ensuring an adequate level of personal data protection as required by the applicable data protection laws.

The personal data controllers and data processors shall establish technological, physical, administrative and procedural safeguards all in line with the industry accepted standards in order to protect and ensure the confidentiality, integrity or accessibility of the personal data processed; prevent the unauthorized use of or unauthorized access to the personal data or prevent a personal data breach (security incident) in accordance with Made Model Kft. instructions, policies and applicable laws.

**Recipients of personal data under the "net-casting.eu" platform:** only business partners of Made Model Kft. that exclusively guarantee the safe process of personal data and declare the use of those data not for commercial purpose.

**Recipients of personal data under the FORGE system:** The personal data will be made accessible to the following categories of recipients: the authorized employees

and representatives of the above listed controllers and processors and to management and owners of Made Model Kft.

The personal data might be made available to other service providers, as data processors, in case Made Model Kft. decides to change its direct marketing platform. In this case you will be informed about the new data processor(s).

The personal data may be also disclosed to the competent authorities as authorized by the applicable laws.

**The period for which the personal data will be processed:** The data will be processed until the consent is revoked or in case of the lack of such withdrawal as long as it is necessary in relation to the purposes described above, but no longer than 10 (ten) years from the collection of the data. After the indicated period expires or I request so, or the data controllers become aware of the inaccuracy of my personal data and I refuse or miss to provide my accurate data, the personal data will be permanently deleted. However, I am aware that controller may retain limited scope of my personal data in order to prove compliance with the applicable laws.

The consent is given voluntarily but the processing of my personal data is necessary to fulfil the purposes described here-above. If consent is not granted or I later send a request for rectification or erasure of my data, and withdraw my consent, this will mean that I will have no possibility to participate in marketing or promotional activities or receive any newsletters or offers from Made Model Kft.

I acknowledge that as a personal data subject before 25 May 2018 I have the right to ask for information about the data processing, request from the controller access to and rectification or erasure of personal data or a restriction on the processing and the right to withdraw my consent at any time. Additionally to the before indicated rights, from 25 May 2018 I, as data subject have the right to object to the processing, as well as the right to data portability and the right to obtain a copy of my personal data controlled. All rights described in this paragraph can be enforced by myself, by sending an e-mail request to the authorized data controller, Made Model Kft.to info@net-casting.eu

I am aware that my personal data collected in relation to the above described purposes (preferences, behaviours and choice of marketing content) may be used as a basis for automated decisions leading to the identification of cooperation opportunities within Made Model Kft. under the "net-casting.eu" platform and theFORGE system. I am aware and accept that under the "net-casting.eu" platform and the FORGE system Made Model Kft. continuously monitors and records whether the online newsletters are deleted unread or are opened, how many times I clicked on the links included and decides accordingly what other topics may be of interest to the organisation contacted through my email address.

I also have the right to initiate a court proceeding against the data controller for indemnification and to lodge a complaint with a data protection supervisory authority in the country of my residence in case I consider that the processing of my personal data infringes the applicable laws.

I understand and provide my consent that my personal data are being controlled by Made Model Kft. as joint controllers and be transferred to "net-casting.eu; mailchimp; FORGE, as contracted data processor, operating the system above used by Made Model Kft. for newsletter sending.
